REF: JOINT TRAVEL ADVISORY No. 3

This Joint Travel Advisory No.3 dated 13th March, 2020 is issued by Ministry of Commerce, Industries, Labour and Immigration together with the Ministry of Health and Medical Services. This Joint Travel Advisory supersedes the Joint Travel Advisory dated 27th February, 2020 and comes into force on the 14th of March.

There is a Public Health Emergency of International Concern (PHEIC) declared by the World Health Organization (WHO) determined to constitute a public health risk to other States through the international spread of disease and requires a coordinated international and national response.

This travel advisory is applicable to all travellers and crew regardless of mode of travel

Based on health advice from the Ministry of Health and Medical Services on the increased risk posed by the spread of 2019 novel coronavirus ("the COVID-19"), the Solomon Islands Government has introduced strict new travel restrictions and revised travel advice. This advice is subject to change at short notice due to the developing nature of the Public Health Emergency

1. Notification for intending travellers:

Annexure A – Restricted Countries

1.1 Effective immediately, any foreign person who has travelled from or transited through the Countries identified in Annexure A ("Restricted Countries") during the 14 days immediately before the day on which the person arrives in Solomon Islands will not be permitted to enter the Country.

1.2 Effective immediately, any Solomon Island nationals who has travelled from or transited through the Countries identified in Annexure A ("Restricted Countries") at any time during the 14 days immediately before the day on which the person arrives in Solomon Islands will be permitted to enter the Country under strict Health criteria, to be advised by Health prior to, or upon arrival in country. Such criteria may include an imposed 14 day quarantine period or other conditions as directed by health officials.

Annexure B - Affected Countries

1.3 Upon arrival all travellers and crew must provide details of their international travel history for the period of 14 days prior

1.4 All travellers and crew will be subject to risk-based assessment by the Solomon Islands Government (SIG) at authorised Points of Entry and may be subject to quarantine restrictions for up to 14 days or monitored by health authorities for 14 days or denied entry.

1.5 Any traveller or crew who is preparing to travel to the Solomon Islands should self-assess their health, and if thought to display symptoms of the COVID-19 virus, are strongly advised not to travel.

1.6 If any person decides to travel to Solomon Islands, such traveller must have their travel history and information readily available upon arrival.

1.7 Any travellers or crew upon or after arrival in the Solomon Islands is mandated to report to Health authorities if they become unwell and display symptoms of the COVID-19 during a period of 14 days after such arrival. Any such person should immediately self-quarantine before contacting Health authorities, and minimise contact with others until Health authorities can assess you.

2. Pre-arrival screening measures:

2.1 The pilot or ship master of all aircraft/ vessels coming to Solomon Islands are mandated to report, upon arrival, presence of sick person on board (symptoms or signs of flu, running nose, fever, headache, chest pain, difficulty in breathing, or rash) using health declaration part of aircraft general declaration or Maritime Declaration of Health as applicable.

2.2 All persons including crew arriving in Solomon Islands either by air or sea **MUST** complete a **Traveller's Public Health Declaration Card**.

2.3 All travellers originating or transiting through Affected Countries and Regions (Annexure B) will be monitored and are mandated to report presence or development of any symptoms within 14 days of arrival in Solomon Islands. They could be subjected to quarantine and/ or isolation as applicable. Persons suspected of or displaying any symptoms of the COVID-19 will be isolated and subjected to future diagnosis or tests by Health Authorities. Any quarantine/ isolation place and period shall be determined and/or directed by Health Authorities.

2.4 All incoming travellers **MUST** complete a Travellers Public Health Declaration and also provide full details of their place of stay, travel itinerary and current personal contact details in Solomon Islands for 14 days after their arrival in Solomon Islands.

2.5 Any person found to be providing false information to the Solomon Islands Government will be prosecuted under the relevant laws of Solomon Islands and this may include imprisonment or deportation.

3. Additional measures specific to incoming maritime vessels and crafts:

3.1 The SIG has currently designated Honiara Port and Noro Port as the only approved Entry and Exit Points of Clearance.

3.2 Approvals under 3.1 shall be conditioned to presentation of mandatory minimum documentation detailed in the Customs directive and/or as requested by the Solomon Islands Government.

3.3 The Customs Comptroller has issued specific directives for maritime traffic. These can be found on the Customs website www.customs.gov.sb

4. Solomon Island Citizens and Residents

4.1 SIG has imposed a "No Travel" restriction upon all members of Parliament and Government Officials to Annexure A countries (Restricted).

4.2 Citizens and residents of the Solomon Islands are advised to avoid and/or defer non-essential travel including conferences and trainings to Annexure A countries (Restricted) and those who travel to such countries shall be subject to measures detailed at 1.1 and 1.2 of this Travel Advisory.

5. General Information

5.1 All persons travelling or intending to travel to and from the Solomon Islands are strongly encouraged to familiarise themselves with these travel restrictions. The following SIG websites will be posting updated Travel Advisories and information related to travel.
